### **Media accreditation and accommodation deadlines looming** ***Council of the Federation Meets in Banff, Alberta, August 10-12, 2005***

**June 28, 2005** – To ensure adequate space is available, media planning to be on board a special passenger train for Premiers and delegates from Calgary to Banff on Wednesday, August 10 must complete the accreditation form, including the section on travel arrangements, by **June 30**. The form is available at [www.gov.ab.ca/premier/cof](http://www.gov.ab.ca/premier/cof).

Due to limited accommodation in Banff during the busy tourist season, media wishing to take advantage of lower conference rates for hotel rooms must contact the accommodation coordinator (see below) prior to **July 4**.

#### **Deadlines:**

##### ***June 30***

- ***Accreditation forms for media travelling by train from Calgary to Banff on Wednesday, August 10, must be submitted (please ensure the section on travel arrangements is complete)***
- ***All media are encouraged to have applications for accreditation submitted***

##### ***July 4***

- ***Accommodations arranged through the conference accommodation coordinator***

#### **Media Accreditation & Accommodations**

Media representatives who wish to attend the Council of the Federation meeting must complete an application for accreditation form. The form is available at [www.gov.ab.ca/premier/cof](http://www.gov.ab.ca/premier/cof). **To avoid on-site delays, all media are encouraged to submit accreditation application forms no later than June 30.**

Applicants will be screened to ensure they are working media.
